## TERMS & CONDITIONS

1. All applications must be **completed fully**, signed and submitted to CBS prior to space reservation acceptance. Please make sure your writing is legible.
2. Your application will be processed by your **last name** so please include it on all correspondence.
3. **Everyone must**, attach a copy of his /her current valid California State BOE permit to their application. <http://www.boe.ca.gov/info/reg.htm>
4. All **NEW VENDORS** must include FOUR (4) photos of your work including **one booth shot if** .
5. Space fee(s) of **\$50** per space, should be included with your application in the form of a check or money order, payable to Congregation Beth Shalom. .
6. Booth size is 10' x 10' unless otherwise indicated. We provide the space only, no canopies, etc.
7. **DEADLINE is MONDAY, April 22, 2019**. Late applications will be accepted if room allows.
8. Please only display items that have been approved by staff onsite.
9. This is a NO COMMISSIONS show.
10. **One piece of art is required to be donated upon arrival at the show**. A suggested value of the piece is \$30. CBS is a 501(c) 3 non-profit organization and your donation is tax deductible.
11. Please ARRIVE by 7 a.m. No vehicles will be allowed in the courtyard after 8:30 a.m.
12. **CANCELLATIONS** must be **submitted in writing**, and received no later than 7 days prior to the event for any refund to apply. A \$25 handling fee will be deducted from any refund. If you cancel after the 7 day deadline no refund will be issued. Please be sure to call (209) 613-9889 so we can try to fill your space. Please allow 4 weeks for refund processing,
13. All applications are juried by category on a first come, first served basis.
14. You will receive a phone call within 2 weeks of submitting your application which will notify you if you were accepted. Applications submitted within 1 week of the show will be notified as soon as possible after receipt of the application.
15. You will receive your space assignment approximately one week prior to the show by e-mail, or text message and will contain space assignments with general booth location, directions to the show, show set-up instructions, etc.
16. Participants are asked to conduct themselves in a professional and tasteful manner at all times. Failure to do so may result in your being asked to leave the show with no refund of fees.
17. Electricity is not provided unless specifically requested prior to the show and is on a first come first served basis.
18. If you have special needs notate them on your application, however, we cannot guarantee anything.
19. **PARKING** is adjacent to CBS at Lady of Fatima Catholic Church, just a few hundred yards from CBS. **PLEASE DO NOT PARK IN THE CBS PARKING LOT OR ON THE STREET**
20. All wares must be within your space.
21. Vendors are responsible for providing their own insurance for the event.
22. We reserve the right to cancel space reservations in the event circumstances beyond our control dictate the need to downsize a layout.
